## China 24HR Advance Manifest Rule

Shanghai Customs has announced that new China Customs Advance Manifest would be implemented in Shanghai from 28th June, 2014.

China Customs has published The Measures for Manifest Administration for Inbound and Outbound Means of Transportation of the People's Republic of China (Decree No.172 of General Administration of Customs) effective on 1st January 2009 and the port of Shanghai will now strictly enforce the new procedure.

After the enforcement date, all shipments on any vessel calling Shanghai Port or transshipping via Shanghai must be <u>filed advance manifest at least 24 hours prior to cargo loading at non-China port.</u> Shipments can only be loaded on approval from Customs.

In case of receiving a "Do not load" message, the shipment cannot be loaded.

Cargo manifest destined and transshipped in Chinese ports as well as export shipments out of Chinese ports on vessel is supposed to be electronically filed to China Customs in the timeframe.

## ■ Scope:

The CCAM 24 Hour Advance Manifest Rule applies to:

Cargo on Chinese ports direct calling vessel:

- a. Import Cargo into China mainland
- b. T/S Cargo at China mainland
- c. FROB (Foreign remain on board ) Cargo is excluded.
- d. Hong Kong, Macau, Taiwan is excluded.
- e. House B/L is not required.

- I Gross Weight Per Commodity Item
- I Name Of Contact Person For Dangerous Cargo (Mandatory for DG Cargo)
- Contact Number Of Contact Person For Dangerous Cargo (Mandatory for DG Cargo)
- I UNDG Number For Dangerous Cargo (Mandatory for DG Cargo)
